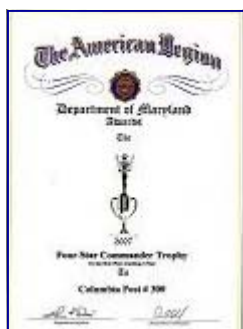

### TAPS copied from Post 154

“Reportedly, it all began in 1862 during the Civil War, when Union Army Captain Robert Ellicombe was with his men near Harrison 's Landing in Virginia .
